In no event shall the undersigned be entitled for any reason to enjoin, restrain or interfere with the distribution, exhibition and/or utilization of the production, its advertising or publicity.

The undersigned hereby represents and warrants that he/she is the sole owner of copyright and all other rights in and to the photos and has the right to enter into this agreement and to grant the rights herein granted, and that the consent of no other person or entity is required to effectuate such grant.

The undersigned further warrants and represents that the use of the photos will not violate or infringe upon the trademark, trade name, copyright (including moral rights), artistic, and/or other rights of any third parties, including but not limited to any rights of privacy, publicity or personality. If the materials depict or represent any living identifiable individuals, the undersigned represents and warrants that he/she has the authority and all necessary consents to grant the rights in this release to the producer to use the photos in the production, and as further herein described. The undersigned agrees to indemnify Vancouver Dispensary Society (VDS), our licensees, successors and assigns, and any parent, affiliate, and related entities, shareholders, directors, officers and employees from and against all claims, damages or expenses resulting from the undersigned's breach of the above-stated representations and warranties.
